Setanta Sports S.a.r.l. (In Liquidation) (“the Company”)

Further to previous correspondence, I can confirm that the Company was placed into Creditors' Voluntary Liquidation on 15 June 2010 and that Neville Kahn, Lee Manning and Nicholas Edwards were appointed Joint Liquidators.
